

What You Need To Do

› Before Thursday, March 9, 2017

Prior to March 9, 2017, please save any eStatements that you would like to have readily available, because past eStatements will not be transferred to the HomeTrust Bank system.

› Friday, March 10, 2017, 3:00 p.m. (EST)

You should begin using your new HomeTrust Bank Business Debit card(s). You will receive your new card(s) in the mail the week prior to the March 10–12 conversion weekend. Your TriSummit Bank Business Debit card(s) will not work for your account(s) being transferred to HomeTrust Bank after 4:00 p.m., March 10, 2017.

› Friday, March 10 at 5:00 p.m. to Monday, March 13 at 9:00 a.m.

- During this time, accounts moving to HomeTrust Bank will be unavailable in Business Connect until 9:00 a.m. (EST) on Monday, March 13, 2017.
- Please note that any transfers scheduled to occur after Friday, March 10, must be entered into your Online Banking system before Friday, March 10 at 5:00 p.m. (EST) to be converted to HomeTrust's Online Banking.

› Monday, March 13, 2017, at 9:00 a.m. (EST)

Log in to your Business Connect profile by visiting hometrustedbanking.com, selecting the green "Online Banking" box, and using the "Business Connect" section.

What You Need To Know

› ACCOUNTS

Any monthly service charges on transferring accounts will be waived on your first statement cycle with HomeTrust Bank in order to provide time for you to explore other HomeTrust Bank account options and make changes if you choose to.

› ACCOUNT NUMBERS

Most account numbers will not change. However, if your account number is subject to change, we will notify you in a separate mailing and work with you to ensure a smooth transition.

› CHECKS

You may continue to use your TriSummit Bank checks until your next order.

› STATEMENTS

On March 10, 2017, a final statement from TriSummit Bank will be produced. You can expect to receive your regular monthly statement from HomeTrust Bank beginning in April.

› eSTATEMENTS

If you currently receive your statements via eStatements, you or your company's designated administrator will need to re-enroll to receive eStatements starting March 13, 2017.

› BUSINESS REMOTE CAPTURE CUSTOMERS

After your accounts have moved to HomeTrust Bank, you will only need to log in to Business Connect to access this service. There is no need to sign on to a separate site—everything will be in one place.
